### **INAUGURAL ADDRESS**

The Excellences of the Institution and the Qualifications of its Members

**Synopsis** 

As an opinion piece, this paper first looks at the institution itself, how the same common thread has been running through its precepts for many centuries and its aspirations are likely to continue for many more. How it sets the tendency for good behaviour and the benefits afforded to its members by so doing.

Secondly, the relationship between the institution and its select membership is examined particularly in regard to the necessity of matching potential members' expectations with the principles of the organisation. As a fraternity, its attractions are essential elements leading to enhanced understanding by its members of the behavioural standards required of them, mirrored by the society's understanding towards its members.

### THE NORMAN B. SPENCER PRIZE ESSAY

Members are reminded that all are eligible to enter the competition whether they live in the United Kingdom or abroad. It was instituted to encourage brethren to take an interest in Masonic research and those who have not previously undertaken study of this kind will find that it is remarkably interesting and satisfying in itself even though their efforts may not be crowned with the award of the prize.

- 1. Entrants may select their own subject which must be within the fields of Masonic history, symbolism, ritual, biography or antiquities (regalia, jewels, furniture, ceramics, glassware, silverware, documents, etc.) or Freemasonry in the press or in municipal architectural, or archaeological archives.
- 2. Ritual matters which are unsuitable for publication will not be accepted. Individual lodge history or local Masonic history will not be accepted unless the subject is of particular historical importance.
- 3. The prize for the best entry in each year is £200 and normally it will be presented at a regular meeting of the lodge, the decisions of the board of assessors must be accepted as final.
- 4. Essays should consist of 5,000 to 10,000 words and must be typewritten in double spacing, with wide left-hand margins.
- 5. Entries will only be accepted on the understanding that Quatuor Coronati Lodge and/or Q.C. Correspondence Circle Limited have the first option of publication. The right is also reserved to exercise normal editorial powers in preparation of essays for publication or delivery and in particular to bring them into conformity with the Quatuor Coronati Style Guide. The copyright of papers so published remains with the authors but it is a condition of any such publication that the authors thereby and thereupon grant to Quatuor Coronati Lodge and/or Q.C. Correspondence Circle Limited the full right to print, reprint, or otherwise publish the same without requiring any further permission from the authors, their heirs or assigns.
- 6. Entries must reach the Secretary of Quatuor Coronati Lodge by 1 June each year.

Attention is particularly drawn to item 1 above. The fundamental purpose of Quatuor Coronati Lodge is Masonic research and entries must be essentially of Masonic content. In particular, those papers of a contemplative or philosophical nature are unlikely to qualify.
